To Whom It May Concern:

I am an attorney licensed in the State of New York and I represent David Voacolo. As a Fannie Mae shareholder, he owns 50,000 shares of the Preferred Class stock.

As a result of 2008 financial crisis, Mr. Voacolo's shares of Fannie Mae stock were placed under a conservatorship for the purpose of bringing the company back t financial health. As you are well aware, the goals of the conservatorship were to preserve and conserve the assets of the company and put the company back into a sound and solvent condition. Once this goal was met, the Federal Housing Finance Agency was supposed to issue an order terminating the conservatorship. However, that never happened.

Under the third amendment of the Federal Housing Finance Regulatory Reform Act, members of Fannie Mae's Preferred Class stock were effectively deprived the possibility of receiving dividends or the liquidation preference, which violated their due process rights under the stock certificate. Although Fannie Mae met the goals of the conservatorship and made profits again, Mr. Voacolo's shares (along with those of many other shareholders in the same class) remained in the conservatorship.

Due to the aforementioned violation of due process, we demand the fair market value of Mr. Voacolo's 50,000 shares in the amount of \$2,000.000 along with damages of \$1,000,00. If we do not hear from you by February 15, 2016, our local counsel in Washington, D.C. will file a complaint against you in the United States Court of Federal Claims.
