The Federal Housing Finance Agency ("FHFA") hereby gives notice that it is withdrawing its Motion to Reconsider Denial of Motion to Substitute (filed October 17, 2016) [D.I. 49] ("Motion to Reconsider") and its Emergency Motion to Compel Production of Settlement Agreement (filed October 25, 2016) (D.I. 52) ("Motion to Compel") in this matter.
