**CONSENT MOTION TO EXTEND DEADLINE FOR *PRO SE* PLAINTIFF’S
REPLY IN SUPPORT OF HIS COMBINED MOTION TO ALTER OR AMEND
JUDGMENT AND FOR LEAVE TO AMEND THE COMPLAINT**

Pro se Plaintiff respectfully moves for a fourteen-day extension of time to May 6, 2019 to file his reply in support of his combined motion to alter or amend judgment and for leave to amend the complaint [ECF No. 27]. Defendants consent to the proposed extension. In support of this motion, Plaintiff states:

1. On March 18, 2019, Plaintiff filed the above-referenced motion [ECF No. 27].
2. Pursuant to Local Civil Rule 7(b) of the Rules of the U.S. District Court for the District of Columbia (the “Local Rules”), the deadline for Defendants to oppose the motion was April 1, 2019.
3. On March 21, 2019, Defendants moved for a two-week extension of time to April 15, 2019 to file their opposition [ECF No. 28]. Plaintiff did not oppose the request.
4. On April 15, 2019, Defendants filed their opposition [ECF No. 29].
5. On April 17, 2019, the Court granted Defendants’ request [ECF No. 30].

6. Pursuant to Local Civil Rule 7(d) of the Local Rules, the deadline for Plaintiff to file his reply is April 22, 2019, which is seven days after Defendants filed their opposition.

7. Plaintiff needs additional time to prepare his reply due to his schedule and other commitments and the holiday season. An extension of fourteen days would not prejudice any party.

8. This is Plaintiff's first request for an extension of time in this action.

9. Plaintiff conferred with Defendants, who consent to the relief requested herein.

WHEREFORE, Plaintiff respectfully requests that the Court extend his time to file his aforementioned reply to and including May 6, 2019. A proposed order granting the requested relief is submitted herewith.
