JOINT STATUS REPORT

The parties hereby submit the following joint status report in response to the Court's May 5, 2022 Order. ECF No. 76.

On June 3, 2022, Plaintiffs filed their Amended Complaint. ECF No. 80. Defendants have reviewed the Amended Complaint and have advised Plaintiffs that they intend to file motions to dismiss. The parties have met and conferred and jointly propose the following briefing schedule:

July 18, 2022: Defendants file their motions to dismiss the Amended Complaint;

August 15, 2022: Plaintiffs respond to the motions to dismiss;

September 9, 2022: Defendants file their reply briefs in support of the motions to dismiss.

At the Court's convenience and discretion: Hearing on motions to dismiss

The parties believe that it is unnecessary at the time for the Court to enter any further case schedule or to address other matters. No party has any present intent to propound discovery or engage in further motion practice while the motions to dismiss are pending, provided that each

party reserves its respective rights, including the right to file other dispositive motions in the future and the right to object to any discovery or further motion practice as premature.

Based on the foregoing, the parties respectfully request that the Court enter their proposed schedule for briefing Defendants' forthcoming motions to dismiss.
