## DEFENDANTS-APPELLEES' RESPONSE IN OPPOSITION TO PLAINTIFFS-APPELLANTS' MOTION FOR LEAVE TO FILE SUPPLEMENTAL BRIEF

Defendant-Appellees Federal Housing Finance Agency ("FHFA"), Sandra L. Thompson, in her official capacity as Director of the FHFA, and the United States Department of the Treasury, submit this response in opposition to Plaintiffs-Appellants' Motion for Leave to File Supplemental Brief, filed June 21, 2022. The proper vehicle for bringing new relevant authority to the Court's attention is a letter of no more than 350 words under Fed. R. App. P. 28(j). Defendant-Appellee Treasury filed such a letter regarding *Calcutt* on June 16, 2022, and Plaintiffs-Appellees were entitled under the Rule to respond in kind. A supplemental brief almost nine times larger than the Rule 28(j) limit is excessive and unnecessary, particularly when the stated need for 3,000 words arises entirely out of matters in a separate opinion that is not the precedential opinion of the Court. If, however, the

Court grants Plaintiffs leave or otherwise considers the arguments in the Supplemental Brief, Defendants-Appellees request an opportunity to submit a responsive supplemental brief within 14 days of the Court's order.
